EXECUTIVE SUMMARY
4th QUARTER FISCAL YEAR 2009

The Office of Inspector General (OIG) was created by Senate Bill 103 and House Bill 914 during the 80th Session of the Texas Legislature, as an independent law enforcement division of the Texas Youth Commission (TYC). Both bills were signed into law in June 2007. OIG was established for the purpose of investigating: (1) Crimes committed by commission employees, including parole officers employed by or under contract with the commission; and (2) Crimes committed at a facility operated by the commission or at a residential facility operated by another entity under contract with the commission.

SB 103 and HB 914 require the submission of quarterly reports to the following:

- The Executive Director;
- The TYC Board;
- The Governor;
- The Lieutenant Governor;
- The Speaker of the House of Representatives;
- The standing committees of the Senate and House of Representatives with primary jurisdiction over correctional facilities;
- The State Auditor;
- The Comptroller; and on
- The Commission's Internet Website.

During the fourth quarter of fiscal year 2009, OIG opened **341** criminal investigations (**9.3% decrease from 3rd quarter**) and completed/closed **377** cases (**15.9% increase from 3rd quarter**), resulting in **6** arrests, **27** indictments, **31** convictions, **18** no billed, and **5** dismissed.








Total Cases by Information Source 6/1/2009 thru 8/31/2009




Total Cases by Status 6/1/2009 thru 8/31/2009




***Investigative Cases Opened by Secure Facility


***Investigative Cases Opened by Halfway House





Assault Cases by Secure Facility 6/1/2009 thru 8/31/2009




Assault Cases by Halfway House


Assault Cases by Contract Facility




Inappropriate Relationship Cases by Secure Facility ***6/1/2009 thru 8/31/2009***




Sexual Misconduct Cases by Secure Facility 6/1/2009 thru 8/31/2009




Sexual Misconduct Cases by Halfway House 6/1/2009 thru 8/31/2009






**Staff Misconduct / Waste, Fraud & Abuse / Destruction of State Property






Total Information Only Cases by Secure Facility


Total Information Only Cases by Halfway House


Total Information Only Cases by Contract Facility


**Total Information Only Cases by Month


Contraband Cases by Secure Facility 6/1/2009 thru 8/31/2009




Contraband Cases by Halfway House 6/1/2009 thru 8/31/2009



Contraband Cases by Contract Facility 6/1/2009 thru 8/31/2009




Escape / Riot / Terroristic Threat Cases by Secure Facility 6/1/2009 thru 8/31/2009




Escape / Riot / Terroristic Threat Cases by Contract Facility




Total SPU Cases by Penal Code 6/1/2009 thru 8/31/2009
