EXECUTIVE SUMMARY

4th QUARTER FISCAL YEAR 2011

OIG was created as a law enforcement division within TYC in June 2007 during the 80th Legislative Session as a result of the enrollment of Senate Bill 103 and House Bill 914. OIG was established for the purpose of investigating: (1) crimes committed by commission employees, including parole officers employed by or under contract with the commission; and (2) crimes committed at a facility operated by the commission or at a residential facility operated by another entity under contract with the commission.

The aforementioned investigative criteria was expanded in June 2009 during the 81st Legislative Session as a result of the enrollment House Bill 3689 and Senate Bill 1020 to include: crimes committed at any facility in which a child committed to the custody of TYC is housed or receives medical or mental health treatment.

Senate Bill 103 and HB 914 require the submission of quarterly reports to the following:

- The Executive Director;
- The TYC Board;
- The Governor;
- The Lieutenant Governor;
- The Speaker of the House of Representatives;
- The standing committees of the Senate and House of Representatives with primary jurisdiction over correctional facilities;
- The State Auditor;
- The Comptroller; and on
- The Commission's Internet Website.

During the fourth quarter of fiscal year 2011, OIG opened **242** criminal investigations and completed/closed **184** investigations. Also during this time period, OIG investigations resulted in **50** apprehensions, **2** arrests, **11** indictments, **3** convictions, and **6** adjudications.






Investigative Cases Opened by Secure Facility 6/1/2011 thru 8/31/2011




***Investigative Cases Opened by Halfway House




Assault Cases by Secure Facility 6/1/2011 thru 8/31/2011




Assault Cases by Halfway House




Contraband Cases by Secure Facility 6/1/2011 thru 8/31/2011




***Contraband Cases by Halfway House




Contraband Cases by Contract Facility ***6/1/2011 thru 8/31/2011***




Sexual Misconduct Cases by Secure Facility 6/1/2011 thru 8/31/2011




***Sexual Misconduct Cases by Halfway House

Sexual Misconduct-Staff/Offender




***Sexual Misconduct Cases by Contract Facility





Inappropriate Relationship Cases by Secure Facility 6/1/2011 thru 8/31/2011




Inappropriate Relationship Cases by Halfway House 6/1/2011 thru 8/31/2011







Escape / Riot / Terroristic Threat Cases by Secure Facility 6/1/2011 thru 8/31/2011
