**AMENDMENT 1 TO CONTRACT NUMBER PS145**

The Texas Juvenile Justice Department, hereinafter "TJJJ" and 63<sup>rd</sup> and 83<sup>rd</sup> Judicial District Juvenile Probation Department, hereinafter "Service Provider," acknowledge that they have previously entered into a contract for the provision of parole supervision and services to youth in the following counties: **Kinney, Terrell, and Val Verde**. This contract is identified as contract number **PS145**.

Both parties wish to continue the relationship that exists without a lapse in services. Service Provider agrees to continue to provide services under the aforementioned existing contract, and TJJJ agrees to continue to use Service Provider's services during the term of this extension. The parties hereto agree to be bound by the terms of the existing contract subject to the following changes:

1. Pursuant to Section IV. General Provisions, Article 10: Contract Term, this contract is being amended to extend for the period of two (2) additional years, beginning on **September 1, 2015 through August 31, 2017**.
2. The total contract amount for the period September 1, 2015 through August 31, 2016 shall not exceed **\$45,000.00 (forty-five thousand)**.
3. **Section IV. General Provisions, Article 13, Notice**, is deleted and replaced with the following

**Article 13: Notice**


Required notices will be provided to the Director of Business Operations and Contracts at the TJJJ Central Office at **11209 Metric Blvd., Bldg. H, Suite A, Austin, TX 78758**; to **San Antonio District Office, 1402 Hackberry, San Antonio, TX 78208** and to the Service Provider at **200 Griner, Del Rio, TX 78840**.

4. Verification of Worker Eligibility
  - a. If Service Provider is not enrolled in the U.S. Department of Homeland Security's E-Verify system ("E-Verify"), Service Provider shall:
    - i. Enroll in the E-Verify program within 30 calendar days of executing this amendment; and thereafter
    - ii. Use E-Verify to initiate, within 3 business days after the date of hire, verification of employment eligibility of all new hires of Service Provider employed during the contract term to perform duties within Texas and all persons (including subcontractors) assigned by the Service Provider to perform work pursuant to the contract, within the United States.
  - b. If Service Provider is enrolled in E-Verify, Service Provider shall use E-Verify to initiate, within 3 business days after the date of hire, verification of employment eligibility of all new hires of Service Provider employed during the contract term to perform duties within Texas and all persons (including subcontractors) assigned by the Service Provider to perform work pursuant to the contract, within the United States.
  - c. Service Provider shall comply with the requirements of the E-Verify program Memorandum of Agreement (MOU). If the Department of Homeland Security (DHS) or the Social Security Administration (SSA) terminates Service Provider's MOU and denies access to the E-Verify system in accordance with the terms of the MOU, TJJJ may terminate the contract.
  - d. Service Provider shall include the requirements of this clause, including this paragraph (appropriately modified for identification of the parties), in each subcontract under the contract that is for services or construction.
  - e. Service Provider shall provide, upon request of TJJJ, an electronic or printed image of the confirmation or non-confirmation screen containing the E-Verify case verification

number for attachment to the Form I-9 for each of Service Provider's employees, subcontractors, and subcontractors' employees that meet the criteria above.

- f. If Service Provider fails to comply with the requirements of this clause, TJJD may terminate the contract, withhold payment, or impose other administrative error sanctions.
- g. The requirements of this clause only apply to contracts for services or construction.



