Effective June 1, 2016, TJJJ will activate a new "Regional Diversion Grant" funding source. This new funding source can be utilized to pay for placements, programs, drug tests, psychological tests, non-residential services, behavioral health services and behavioral health treatments. However, the expenditure is only reimbursable if it conforms to an approved diversion plan.

Enter **Regional Diversion Grant** as the funding source when it is determined that your department will apply for reimbursement through the Regional Diversion Alternatives (RDA) program. If reimbursement is denied, edit the record to select a different funding source.

Adding a Funding Source Code

To add the Regional Diversion Grant funding source to JCMS, do the following:

1. From the JCMS Home Screen, select Maintenance.
2. Select Funding Sources.
3. Click Add New.
4. Enter the Funding Source Description - **Regional Diversion Grant**.
5. Enter the Activation Date of 06/01/2016.
6. In the TJJJ Funding Source Type box, select **Regional Diversion Grant**.
7. Click Save.

JCMS Buzz – May 2016

Transferring a referral out of your county prior to Adjudication/Disposition

When your county transfers a formalized referral to another county prior to adjudication/disposition, the disposition you enter will vary depending on when the case was sent out.

- If transferred by the probation department, your department will enter the disposition of "Dismissed or Withdrawn".

- If transferred by the prosecutor, your department will enter the disposition of "Refused".
- If transferred by the court, your department will enter the disposition of "Transferred with No Disposition".

JCMS Buzz – March 2016

Please stress to your staff the importance of entering Diagnosis information into JCMS. This information is crucial to our Research team when gathering information about the youth served by juvenile probation departments. Below are a few tips:

- The Behavioral Health Status Screen should be updated as the juvenile's Mental Health Needs change or as your department is made aware of the juvenile's Mental Health Needs.

- If a juvenile's only diagnosis is Substance Abuse, this Diagnosis **alone** doesn't qualify the juvenile as Mental Health Needs = Yes, as recorded on the Behavioral Health Status Screen.
- Only Diagnoses entered on the Behavioral Health Status Screen are transferred to TJJD through the monthly extract.
- If your department enters a Diagnosis (other than a Substance Abuse Diagnosis) on the Psychological Test Screen, this information must also be entered/updated on the Behavioral Health Status Screen.

JCMS Buzz - September 2015

Effective September 1, 2015, TJJD will retire four funding source categories and activate 10 new

ones. The retirement and activation of these categories will require the JCMS System Administrator in each department to make updates to JCMS. The new funding sources may be used in records that begin on or after September 1, 2015. Therefore, it is not necessary to close a service, program, or placement funded by one of the retired funding sources.

A webinar covering the data reporting requirements of the new funding sources is scheduled for Thursday, September 10th at 2:00pm. Registration information will be provided by our Research division later this week.

Retiring Funding Source Codes

The four funding source categories that need to be retired are:

- State Aid Grant (TA)
- Commitment Reduction Grant
- (TC) C Grant Blended (T*)
- N Grant Mental Health Services (TN)

To retire a funding source in JCMS, do the following:

1. From the JCMS Home Screen, select Maintenance.
2. Select Funding Source.
3. Click Edit next to the funding source to be retired*.

Addition of Disposition Categories – September 2015

TJJJ has expanded the list of Disposition Categories to include **Adjudicated to Probation with Placement** and **Modified/Extended to Probation with Placement**. These two new disposition categories were added to capture disposition outcomes resulting in residential placement. Under the new Regional model, there will be an increased focus on residential placements. The new codes allow the research department to track placement dispositions without having to link dispositions to placement records. This will help improve the research department’s ability to track recidivism of youth

on probation in the community separately from youth on probation with placement. The new disposition categories also correspond to DPS Court Disposition Provision codes which captures probation with placement.

Adjudicated to Probation with Placement (115) - This is a disposition option set forth in Texas Family Code Section 54.04(d)(1) in which a juvenile who has been found to have engaged in delinquent conduct and/or child in need of supervision is formally placed on probation under the supervision of the juvenile court for a specified period of time. The adjudicated juvenile is placed on probation and ordered to placement in a special facility. The juvenile may be required to participate in a variety of appropriate programmatic services (e.g., counseling, treatments, programs, etc.), and may also be subject to other reasonable court-ordered restrictions or conditions.

Modified/Extended Probation with Placement (125) - Authorized by the Texas Family Code Section 54.05(m)(1), this is an extension or revision of a prior court order in which the juvenile continues probation and is ordered to placement in a special facility. This extension may result in additional supervision time or other programmatic sanctions and/or services (e.g., counseling, drug rehabilitation program, mental health treatment, etc.).

Counties are required to use these two new disposition categories when applicable. These two new TJJD Disposition Categories have been added under Maintenance in JCMS. Each county will have to either modify existing disposition codes already created in JCMS, or create new disposition codes to access these new categories. Instructions to both update existing codes and to create new disposition codes are provided below.

UPDATING EXISTING DISPOSITION CODES

Some counties already have disposition codes designated to track adjudications to probation with placement and modifications/extensions of probation with placement. For these counties, it is not necessary to create new disposition codes. Use the steps below to update these existing codes with the new category.

Entering information into JCMS in a timely manner

Information entered into JCMS is submitted to TJJJ only one time per month; through your monthly extract submission. The extract process transfers information to us that was entered into JCMS, or last updated in JCMS, in the previous month. This means that the extract you submit by August 10, will transfer all data entries made/updated July 1 – July 31.

Any information entered from August 1 through the date your extract is submitted, will not be received at TJJJ until you submit your extract in September for data that was entered/updated in August.

TJJJ reports disposition information to the Legislative Budget Board (LBB) on a monthly basis. If all disposition information can be entered by the end of the month, the data we submit to the LBB will be more accurate. **Please review and update your data entry prior to the end of the month so the data will be transferred to TJJJ in the first possible extract.**

Changes coming regarding Special Education Handicapping Conditions – Action Required

Effective September 1, 2015, the list of Special Education Handicapping Conditions will be expanded to match the list provided by the Texas Education Agency. Additional information regarding these new options will be provided next month. In preparation for this change, we are asking each county to make sure that your School Information is up-to-date. If a juvenile has been reported as Special Education, please insure that this information, along with their Handicapping Condition, is entered on the School Screen prior to September 1, 2015.

Entering Funding Sources

While Funding Source is not a required field on the screens throughout JCMS, TJJJ uses the Funding Source information entered on these screens to determine how your department spends grant money: which programs, placements and services are funded with TJJJ grant money; how many juveniles are served with TJJJ grant money; the average length of programs and placements and the outcomes of these services, programs and placements.

If TJJJ grants are used to pay for Behavioral Health Services, Behavioral Health Treatment, Programs, Drug Tests, Non-Residential Services or Placements, please enter the appropriate funding source in JCMS. Updates to these screens can be made after the program, placement, etc. has been completed.

Beginning September 1, 2015, TJJJ will expand the list of funding sources. More information regarding these funding sources will be provided over the next few weeks.

Entering TSDS Numbers in JCMS - May 21, 2015

PLEASE PROVIDE THIS INFORMATION TO YOUR EDUCATION PROGRAMS:

All students in Texas schools, as of the 2012-2013 school year, were provided a new TSDS Unique Student Identification number, a 10 digit number, along with their usual PEIMS number. Students were already assigned their number that will be with them the rest of their school career. All school districts will be transitioning to the new Texas Student Data System (TSDS) system that will take the place of the PEIMS data management system over the next few years and will require the use of this new unique student identification number on student records.

I am requiring both PEIMS and TSDS numbers be submitted by all JJAEP counties for student entries from the 2014-2015 school year forward, so that once every school district is transferred over to the TSDS data management system, we will be able to communicate with TEA to get the student data we need to complete our required Legislative reports. On withdrawal forms, I have seen that the TSDS number is on every Texas Records Exchange (TRex) report at the top right area; and labeled as 'unique ID, TSDS Unique ID, or Texas Unique ID'. The number may yet have other names in other districts, but seems to be placed just below the PEIMS ID number. Please ensure that your registrar/data input coordinator

In JCMS, the TSDS number may be entered either in the ID Numbers section of the Juvenile ID Screen or on the JJAEP Screen. Entering the information in one of these screens automatically populates the field on the other screen. Once entered in a juvenile's JCMS record, the TSDS number can be found on the Juvenile ID Screen, the JJAEP Screen (if applicable), the juvenile banner inside a juvenile's folder, the Search Results Screen and on the Case History Report.

JCMS Standard Practice for Photo in Juvenile Banner – May 2015

Below are the 'best practices' for juvenile photos uploaded to the JCMS Banner:

- The photo should **ONLY** include the juvenile's head and shoulders with shoulders square to the camera.
- The photo should be in color and taken on a gray or neutral background and should not contain shadows.
- Head coverings, including hats and scarves, should not be worn. The full face and ears should be displayed.
- When possible, the juvenile's hair should be moved to reveal the full face and ears.
- For subjects who normally wear eyeglasses, every effort should be made to capture the photo with the glasses on. The wearing of eye patches is allowed only for medical reasons.
- The expression should be neutral (non-smiling) with both eyes open normally (i.e. not wide-open), and mouth closed.

JCMS BUZZ: May 2015**Program Update**

Historically, TJJJ requested that counties close "Community" programs when a juvenile was placed into detention. "Community" refers to the Program Location assigned to each program. Program Location notifies TJJJ where the juvenile resided during his/her participation in the program. In past years, this rule was changed to allow "Community" programs to be opened for up to 8 days while a juvenile was detained.

This rule has been updated once again to accommodate the 10-day detention hearing. TJJJ will now allow a juvenile to be in a "Community" program and in detention at the same time for up to 10 days. If a juvenile will remain in detention beyond 10 days, please close all "Community" programs. If the juvenile will resume the program when he/she is released from detention, a new Program Screen should be opened.

If the juvenile will continue to participate in the same program while in detention, the "Community" program should be closed and a new Program Screen should be opened to track the "Detention" program. A "Detention" program would be assigned the Program Location of "Detention".

Holidays – November 10, 2014

JCMS has a new Maintenance option which allows each county to enter their own holidays.

To enter Holidays, do the following:

- On the Home Screen, select Maintenance from the Other Tasks box.
- Select Holidays.
- Click Add New to add a holiday.
- Select the Date by using the date picker and enter a Description of the holiday (Ex. Christmas).
- Click Save.

JCMS Help Desk Procedures

1. Department staff should contact their department's Data Coordinator or other JCMS designee for all JCMS questions.
2. When issues cannot be resolved in-house, the Data Coordinator or other designee will contact the JCMS Help Desk at TJJJ. All JCMS questions should be sent to the Help Desk and not to individual TJJJ staff. The Help Desk phone number is 512-490-7724 and the email for JCMS questions is jcmssupport@tjjd.texas.gov.
3. The Help Desk will contact the CUC for any issues that cannot be resolved by TJJJ staff.

Originating Jurisdiction PID

In most instances, Interim/Permanent Transfer Referrals (TR), Contract Placement Referrals (CP) and Contract Detention Referrals (CD) track juveniles in your county who have been sent to you from another Texas county.

In December 2013, the Originating Jurisdiction PID field was added to the Referral Intake Screen in both JCMS and CASEWORKER. This field should be completed for all TR, CP and CD referrals on or after November 1, 2013. Because your department may create these referral types prior to receiving the PID assigned in the originating jurisdiction (home county), you are not required to enter the Originating Jurisdiction PID at the time the referral is created. However, the Monthly Extract Report will list all TR, CP or CD referrals without an Originating Jurisdiction PID. Below are frequently asked questions regarding this field.

1. We received a TR referral from a county that does not use JCMS. The juvenile's PID is only 5 digits. How do we enter this in JCMS?
 - A. JCMS requires a 10 digit number for this field. For counties that aren't on JCMS, you'll enter their

county number + any filler 0's + the PID from the home county to get a 10 digit number. Example: If the home county is Denton (061) and the PID in the home county is 654, then you would enter 0610000654.

2. We are detaining a juvenile as a Contract Detention for Arkansas so he does not have an Originating Jurisdiction PID. What do we do?
 - A. Enter the Originating Jurisdiction PID as 9999999999 for any juvenile who does not have a PID from a Texas county. This includes juveniles that you detain for other states or other government agencies (FBI, INS, etc.).
3. We have received errors on the Monthly Extract Report that the Originating Jurisdiction PID wasn't entered for a TR referral, but when we check the Referral Screen the information is entered. What should we do?
 - A. Until recently, if a secondary screen (Program, Supervision etc.) was transferred to TJD through the extract process, the Originating Jurisdiction PID information for the associated referral was not being transferred correctly. The field was being transferred as Blank (0000000000) which generated extract errors. This issue was resolved in Sprint 24 which was deployed to production on March 12, 2014.
