- Collaborative effort between TJPC, Bexar, Dallas and Tarrant Counties
- Development of a Comprehensive Case Management System
 - Enables standardized juvenile case management
 - Incorporates new technologies including the World Wide Web
 - Implements industry-standard security practices
 - Leverages solid foundation of CASEWORKER & Dallas County's JIS systems
 - Integrates robust data sharing capabilities



What is JCMS?


- “JCMS” is the evolution of Caseworker
 - Records Juvenile (Child), Referrals, Offenses, Placements, Programs and Supervisions
 - Facilitates monthly reporting to TJPC and DPS
 - Enables real-time Cross-County data sharing;
 - Interfaces with Law Enforcement/Municipal Courts, School Districts, Department of Public Safety, Prosecutor/Court, External Placement Providers and possibly others
 - Built as a web-enabled application

JCMS: Getting Ready – TJPC

- Integration of EDI reporting into JCMS
- Development of a comprehensive migration framework from Caseworker to JCMS
 - Identify data sets/codes that need to be defined in JCMS
- Creation of JCMS training curriculum
- Establishment of implementation timeline



JCMS: Getting Ready – JPD

- Data clean up
 - Need to have “first class” data
- Back up! Back up! Back up!
 - Insure you have good back up of your CW data
- Identify all codes
 - Many of these will have to be imported/created in JCMS
- Identify user-defined fields
 - These have to be mapped to JCMS data elements
- Develop your security matrix and user list




JCMS: Hardware Requirements

- Desktop Computer:
 - No specific hardware requirements
 - Standard “current” desktop should be adequate
 - Must have access to the internet
- High Speed Internet Access:
 - Broadband internet access at a minimum
 - Dial-up access is insufficient
- Implement “trusted connection”
 - Implement “VPN” security at either the network level (hardware) or install “VPN” client (software)



JCMS: Benefits

- Minimizes Server Hardware/Software
 - No longer need CW server or SQL Server software
- JCMS Back up
 - Handled as a Data Center service
- System updates
 - No longer involved in performing system updates
 - These will be done at the Data Center
- Built-in online help & tips


