

Creating CD and CP Referrals for Violation

Contract Detention/Contract Placement Referrals and violations

TJJD added two new violation offenses for CD and CP Referrals. These new offenses allow a detention or placement facility to track juveniles detained or placed for violations ordered in their home jurisdictions. These offenses do not require an 'Original Referral' to be entered on the Referral Screen. Detention and placement facilities are not required to use these new offenses. These two offenses cannot be used in Formal, Paper Formalized or Paper Complaint Referrals. The two new offenses are:

- Violation of Court Order – CD Referrals Only (50129007)
- Violation of Court Order – CP Referrals Only (50129008)

Creating a CP referral for Violation of Court Order – CP Referrals only

- Start at the Offense Screen.
- Create an offense record for **Violation of Court Order – CP Referrals Only**.
- Create a Contract Placement Referral (CP) and attach this **Violation of Court Order – CP Referrals Only** offense.
- Enter the **Not Applicable** Disposition on the Referral Disposition Screen.
