

JCMS Basic – Offense vs. Referral dispositions and Adding Subsequent Dispositions


SCENARIO

JCMS has two options for adding a disposition to a juvenile’s record. One option is the referral disposition which is accessed from the referral screen. The second is the offense disposition, or the disposition container. It’s accessed by hovering over ‘**Juvenile**’ on the juvenile’s page and selecting ‘**Disposition**’ from the drop down menu.


